



## IMPORTANT NOTICE TO ALL PATIENTS AND VISITORS:

VMH Healthcare COVID-19 Modified Visitation Policy  
Effective Wednesday, September 14, 2021

Vernon Memorial Healthcare continues to evaluate its COVID-19 precautions to ensure a safe place to work and receive care. We have the following visitation policy in place for the hospital, all clinics, and the emergency department.

### Prohibited visitation

- Visitors experiencing or having experienced any COVID-19 symptoms within the last 2 days are not permitted—even if the visitor is the primary support person and/or healthcare decision maker:
  - Fever or chills
  - Cough or sore throat
  - Shortness of breath or difficulty breathing
  - Muscle/body aches
  - New loss of sense of taste or smell
  - Recently tested for COVID-19 / awaiting test results
  - If you have been exposed to anyone in the previous two weeks with COVID-19
- Connectivity will be made via telephone to support patient and provide decisions.
- Visitors who have had a diagnosis of COVID-19 in the last 10 days or who have been told to quarantine OR who have had known exposure within 14 days are not permitted.
- Patients who are COVID+
  - Exceptions:
    - Patients <18 years of age
    - Patients giving birth
    - Patients at end of life (as determined by VMH)
    - Patients clinically unable to participate in their care

### Expectations for all permitted visitors

- Must pass entrance screening (exception: COVID+ adult accompanying a minor if no alternative support person available/appropriate).
- Visitors are always required to cover their nose and mouth with a face covering. This is without exception. Visitors who cannot tolerate a personal face covering will not be allowed to visit. Signage is posted to provide guidance on acceptable face coverings.
- Visitors must respect social distancing (maintain six feet of separation between themselves and others) even when wearing a face covering.
- Visitors should visit in the patient's room and plan to remain in the patient's room for the duration of the visit.
  - Exceptions:
    - If there is an aerosolizing procedure, or visitors are directed out of the room by staff, the visitor would be directed to an internal waiting space.

- Visitors may also leave the patient’s room to access the cafeteria and gift shop.
- Frequent hand hygiene should be performed by all visitors. Hand hygiene may include washing hands with soap and water or using an alcohol-based hand rub.
- If Support person becomes ill with COVID-19 symptoms, they should leave and contact the their Primary Care Clinic for appropriate screening including possible testing. They can identify an alternate support person or wait for test results. They may return when test result is negative or appropriate quarantine period has elapsed.
- COVID+ patients (OB and Pediatric) – the support person must wear a mask and face shield and stay in room. Meal trays can be purchased and delivered to patient room.

Outpatient surgery, inpatient surgery, and/or other procedures occurring in the operating suites	1 Support Persons. No one younger than 16 years may visit. May visit pre- and post-operatively in the ambulatory surgery area. During surgery, please make plans to leave the building.	Surgery
Hospitalized Patients (Adults and Pediatric)	1 Support Persons. No one younger than 16 years may visit.	Hospital Observation and Inpatient
COVID+ Hospitalized Adult (18+) COVID+ Hospitalized Obstetrics	No Support Persons. Obstetric patients may have 1 Support Person. See "Expectations for All Permitted Visitors" re: COVID+ patients	Hospital Observation and Inpatient Units-Emergency Department
COVID+ Hospitalized Peds (17 years of age and younger)	1 Support Person 18 years of age or older. See "Expectations for All Permitted Visitors" re: COVID+ patients	Hospital Observation and Inpatient Units-Emergency Department
Hospital End of Life (Determined by VMH)	Up to 2 Support Persons at one time, 16 years of age or older.	Hospital Observation and Inpatient Units-Emergency Department
COVID+ Hospital End of Life (Determined by VMH)	1 Support Person every 24 hours. Support persons should be 18 years of age or older.	Hospital Observation and Inpatient Units-Emergency Department

Ultimately, all restrictions that are being put in place are for the safety of you, our patients, and the communities we serve. The above policy has been approved by the Administrative Team, if there is a discretionary need for an exception in the Hospital setting, the Charge Nurse has the authority to make that determination.
